## **Job Description**

<b>General Summary</b>	The safety and claims manager is responsible for leading, managing, developing, and organizing the department's employee safety and health programs; mitigating risks and limiting liability related to fleet vehicles, general liability, worker's compensation, and property damage involving the department; ensuring compliance with federally mandated drug and alcohol testing programs; collaborating with districts and divisions to eliminate or reduce employee exposure to hazards in the department's various work environments. Responsibilities are performed under general supervision.
<b>Minimum/Required Qualifications</b>	Bachelor's Degree: Safety/Risk Management, Industrial Safety, Business Administration, Public Administration, Human Resources or related field  Eight years of experience in an area related to safety/risk management.
<b>Supervisory Responsibilities</b>	Full Supervision
<b>Location</b>	Central Office - Risk and Benefits Management
<b>Special Working Conditions/Job Characteristics</b>	Job requires occasional, statewide, overnight travel.

## **Examples of Work**

- (1) Works with appropriate districts/divisions to develop safety policies, rules, and regulations and related training programs.
- (2) Answers and interprets safety concerns, employee health, drug/alcohol testing questions, and policy issues.
- (3) Manages drug/alcohol testing programs and pre-employment/post offer physical programs; evaluates and recommends changes to network providers for these programs.
- (4) Oversees and monitors loss control investigations; reviews employee incidents, performs loss analysis, and develops preventative measures; identifies process changes that will improve employee safety and health.
- (5) Supervises activities of the claims unit including investigation, negotiation, and resolution, as well as settlement of general liability, fleet vehicle liability, property damage, and worker's compensation subrogation claims.
- (6) Coordinates activities involving self-insurance plan including applicable outside contracts; supervises

preparation of annual reports.

- (7) Reviews all claims submitted by outside contract adjusting company and staff; extends appropriate settlement authority.
- (8) Reviews assignments of claims and final closings while directing independent claims investigators on claims that require immediate investigation when department investigators are not readily available.
- (9) Conducts negotiations of large claim settlements; audits and reviews all closed files; assists Chief Counsel's Office with litigated cases.
- (10) Prepares data for annual actuarial study; reviews and analyzes the study regarding future funding of self-insurance plan.
- (11) Reviews various data to determine potential liability exposure to the department; handles controversial contacts with the general public, insurance companies, attorneys, legislature, and employees.
- (12) Directs the evaluation and testing of safety equipment, products, and procedures.
- (13) Represents department and risk management on various national, state, and internal committees; attends and contributes to various quick action teams.
- (14) Performs supervisory responsibilities in a manner consistent with the department's Affirmative Action Program.
- (15) Performs other responsibilities as required or assigned.
